# **Out-patient fees**

#### **Specialist fees**

We reimburse specialist fees to the value of not more than the amounts shown below for treatments in Malta or in line with Bupa's equivalent schedules in the country of treatment and/or reasonable and customary charges whichever is the lower.

When admitted for surgery, the specialist fees for surgical procedures cover normal, routine post operative care on the day of surgery. The daily fee is payable for each day following the surgery which patients customarily take to recover. Extended stays beyond this period must be supported by a medical report from the attending specialist.

We reimburse oncologist fees for clinical supervision and planning for the delivery of chemotherapy and/or systemic anti-cancer therapy as follows:

# **Surgery fees**

We reimburse surgeon, anaesthetist, and radiologist fees for coded procedures to the value of not more than the amounts shown below for treatment in Malta or in line with Bupa's equivalent schedules in the country of treatment and/or reasonable and customary charges whichever is the lower.

# Multiple procedures for specialists:

When two procedures are carried out at one operation the maximum benefit payable is 125% of the most complex procedure. When three (or more) procedures are carried out at one operation the maximum benefit payable is 140% of the most complex procedure.

### Multiple procedures for hospitals:

The theatre fee will be reimbursed at 100% of the most complex procedure; and 50% of the next most complex procedure.

When three (or more) procedures are carried out at one operation, an additional 25% of the third most complex procedure is paid.

### Unbundling:

Certain combinations of codes cannot be invoiced together for procedures performed by the same consultant, on the same Bupa customer, in the same setting on the same day. This is also known as 'unbundling'.

#### Some coding principles include:

- o when one procedure is already included in another
- similar/identical procedures
- o when a more appropriate code is available

If we receive an invoice for unbundled procedures for a patient's treatment on the same day in the same setting, we will only fund the highest value procedure in the unbundled combination.
